TERMS AND CONDITIONS FOR GREAT EASTERN MOTORCYCLE TOURS, LLC

TOUR OPERATOR - is Great Eastern Motorcycle Tours, LLC., located at 30 Burbank Road, Ellington, CT 06029

Tour Booking Forms and Hold Harmless Agreements - with signature on these forms, you accept these terms and con-

ditions as a binding contract between Great Eastern and you, the participant. We cannot accept any person on any tour without a duly signed booking form. Every participant must also sign a waiver which is called the Hold Harmless Agreement.

Reservation and Deposit - A non-refundable booking deposit is required at the time of booking. The deposit is \$750.00 and is non-refundable. This deposit secures space for the tour. The balance is due in full 90 days from date of departure. If the balance is not paid, Great Eastern reserves the right to treat this reservation as cancelled and charge the cancellation fee.

The Tour May Include - Transportation of your motorcycle to the destination site or a rental, hotel/motel accommodations in a double or twin room; single tour members can pay the supplement fee for single occupancy. Full breakfast each day. Some meals, and site support truck, and a tour guide. Some sight-seeing fees may be included with your tour. If advertised, airfare may be included. Tour does not include any other items of a personal nature.

Baggage - Great Eastern assumes no responsibility for loss, damage or delay in delivering baggage to tour participants. Baggage turned over for transport each day to Great Eastern is done so at participants own risk.

Cancellation and Refunds - Cancellations received more than 90 days prior to departure will be subject to a forfeiture of the deposit fee. Less than 90 days prior to departure will be subject to the following forfeit of tour cost: 89-45 days - 70% of tour cost; less than 45 days, 100% of tour cost. Exceptions to this policy cannot be made for any reason. *Trip cancellation insurance is strongly recommended*.

Tour Cancellation - In this case the customers will be notified forthwith. Great Eastern will offer to operate the tour if all customers agree to pay any supplemental changes. If customers do not agree to changes, then Great Eastern will refund the customers the full amount paid. Great Eastern is not liable for any additional costs of losses incurred by tour participants due to cancellation. Great Eastern reserves the right to cancel tour if 10 or less participants have not paid in full for tour. Great Eastern is not required to make any refunds once tour commences regardless of the reason for participant being unable to complete his or her tour.

Alterations to Tour Schedule - Some tours operate where seasonal variances and/or weather conditions cause changes in the tour routing and/or accommodations. The itinerary will be adjusted accordingly and alternate hotels, restaurants and roads will be used. (The weather in the touring area is usually pleasant). Great Eastern cannot be held responsible for conditions that may alter the tour Every consideration will be given for the group's safety and no refunds will be made for missed events.

Verbal Changes - Verbal changes of contract are invalid unless confirmed in writing by Great Eastern.

Minimum Tour Participants - Up to 30 days prior to tour departure date, Great Eastern can cancel a tour if 10 or less bikers have not booked or paid in full for a tour.

Insurances - Great Eastern recommends that you take out *adequate travel, health* and *accident insurance* as well as *trip cancellation insurance*.

Non-observance of Traffic Laws and Group Travel Regulations - If the customer does not comply with traffic laws or the requirements for group travel, the contract may be cancelled by Great Eastern and if applicable, the rental motor-cycle secured. The use of alcoholic beverages or drugs when riding in a group is strictly prohibited.
